

## Great State Voucher

### Terms and Conditions

1. In these terms and conditions:

**Accommodation** means an overnight stay (minimum one night) at a participating accommodation provider. All participating accommodation providers are listed on [southaustralia.com/voucher](https://southaustralia.com/voucher) together with their offers under this campaign.

**Booking Period** means the period between 9am (ACDT) on 7 January 2021 to 5pm (ACDT) on 31 January 2021.

**Great State Voucher** means a unique identifying code issued to you by the South Australian Tourism Commission (**SATC**) enabling you to take advantage of discounted Accommodation offers. The number of Great State Vouchers available are limited and as such your Great State Voucher may be subject to availability and eligibility.

**Travel Period** means the period between 7 January 2021 and 31 March 2021 inclusive (excluding Saturday nights).

2. By applying for a Great State Voucher you are deemed to accept these terms and conditions. You are eligible for a Great State Voucher if:

- (a) you reside in Australia; and
- (b) you are aged 18 years and over at the time of registration.

You will be asked to provide proof of identification and a valid email address. If you do not have official identification, the SATC may ask for details such as date of birth and proof of address to verify your eligibility.

3. The SATC is the final determinate in relation to your eligibility for the validity of the Great State Voucher.

4. Each eligible resident is entitled to:

- (a) 1 x Great State Voucher available to apply towards Accommodation with a participating accommodation provider in the 5000 and 5006 postcodes (**Adelaide CBD**) with a value of \$100 (inclusive of GST); and
- (b) 1 x Great State Voucher available to apply towards Accommodation with a participating accommodation provider anywhere else in South Australia with a value of \$50 (inclusive of GST).

5. In order to obtain your Great State Voucher(s) you need to visit [southaustralia.com/voucher](https://southaustralia.com/voucher) and enter the details requested. If you wish to access one of each Great State Vouchers available, then you will need to apply separately for each Great State Voucher.

6. You will be notified of your Great State Voucher by email and SMS where an Australian mobile number is provided. It is important that you do not lose your Great State Voucher. You are only eligible for one of each Great State Vouchers on offer and you will not be able to reapply for a second.

7. The Great State Vouchers will be made available during the Booking Period, or until all Great State Vouchers have been claimed.

8. You must redeem your Great State Voucher during the Booking Period. If you have a Great State Voucher that has not been redeemed by the end of the Booking Period the Great State Voucher

will automatically expire and you will not be able to redeem it to take advantage of Accommodation offers under this campaign.

9. You may redeem your Great State Voucher for travel during the Travel Period. Saturday nights are strictly excluded. In order to redeem your Great State Voucher you need to take the following steps:

- Step 1** Access [southaustralia.com/voucher](https://southaustralia.com/voucher) during the Booking Period for a full list of participating accommodation providers and their offers. You will not be able to access these offers after the Booking Period.
- Step 2** Make yourself familiar with the range of offers available with participating accommodation providers and choose the offer you wish to redeem. Contact the accommodation provider in the way they have specified to complete your booking. Your booking must be complete within the Booking Period.
- Step 3** Book your Accommodation with a participating accommodation provider and provide your Great State Voucher to the accommodation provider in order to redeem the offer. The booking must be for travel within the Travel Period, excluding Saturday nights.

10. You are responsible for all costs and fees associated with your booking for Accommodation and your travel. Costs associated with accessing the SATC's portal for registration for a Great State Voucher and any costs associated with making your booking with an accommodation provider remain yours alone.

11. The SATC is not responsible for any loss of opportunity or liable to provide any replacement value for a Great State Voucher if an eligible resident fails to complete the steps required during the Booking Period to access a Great State Voucher or properly redeem the Great State Voucher with the accommodation provider.

12. You are not entitled to:

- (a) redeem your Great State Voucher for cash; or
- (b) obtain a refund for the value of the Great State Voucher for bookings with accommodation providers that are subsequently cancelled or changed by you; or
- (c) transfer or otherwise attempt to assign your Great State Voucher to another person or entity.

13. The standard terms and conditions of your chosen participating accommodation provider apply to your booking. This includes without limitation all terms and conditions relevant to your stay and all terms and conditions relevant to a cancellation or change in your stay.

14. By participating in this offer and registering for a Great State Voucher you are acknowledging and consenting to the collection, use and sharing of your personal information as specified in the [Data Collection Consent](#) and the SATC's [Privacy Policy Statement](#).

15. You must not act unfairly or dishonestly or try to influence the Great State Voucher campaign by disruption or harassment of SATC employees, accommodation providers or the registration system itself. If the SATC decides that you have acted unfairly, dishonestly, or in disruption or harassment then in its sole discretion the SATC may elect to revoke your Great State Voucher and otherwise reserves its rights.

16. The SATC reserves the right to modify, postpone, cancel or amend the Great State Voucher campaign or these terms and conditions in whole or in part at anytime without notice.

17. These terms and conditions are governed by and construed in accordance with the laws of South Australia and the parties submit to the exclusive jurisdiction of that State.
