

Terms and Conditions 'Ultimate Murray River Escape 2023'

How to Enter

To enter the South Australian Tourism Commission's **Ultimate Murray River Escape 2023** (the "**Promotion**") simply go to www.southaustralia.co.nz and complete the entry form.

Prize

There is ONE (1) prize to be won (the "**Prize**"). The Prize consists of the following for the Prize winner ("**Winner**") and ONE (1) travel companion of the Winner ("**Companion**"):

- travel flying Air New Zealand Economy class "The Works" from Auckland to Adelaide, South Australia (including domestic New Zealand connections from Wellington or Christchurch, if required);
- Two nights' accommodation in Adelaide in a two bedroom apartment staying at Oaks Embassy or Oaks Horizons Adelaide twin share (1night pre and post cruise), excluding breakfast
- A 4night houseboat holiday on Unforgettable Houseboats <u>Parachilna Sunset</u> (2x bedroom, 2x bathroom) for four people excluding petrol and food/beverage costs.
- Return transfers from Adelaide to houseboat departure point with Unforgettable Houseboats (includes 1 hour shopping time)

Terms and Conditions

- 1. Entry in the Promotion is open to residents of New Zealand aged 25 years and over only holding a current full drivers license.
- 2. All employees of the South Australian Tourism Commission, TBWA New Zealand Ltd (Creative Agency), Dentsu New Zealand (Media Agency), Boyd Public Relations Ltd (PR Agency) and participating companies and/or agencies associated with this Promotion and are not eligible to enter. Immediate family of such employees (including spouses, grandparents, parents, children and grandchildren) are not eligible to enter. Ineligible entries will be deemed invalid.
- 3. The opening date for entries for the Promotion is 12am Monday 23 October 2023. The closing date for entries for the Promotion is midnight on Thursday 30 November 2023.
- 4. The Winner will be decided by random draw held on Monday 4 December 2023 with ONE (1) Prize winner in total drawn. The Winner will be contacted by South Australian Tourism Commission via email using the contact address(es) submitted on the Winner's entry form. Where the Winner cannot be contacted by email after three attempts South Australian Tourism Commission will select another winner.

- 5. The South Australian Travel Commission's decision is final, and no correspondence in relation to the Promotion or the selection of the Winner will be entered into.
- 6. The Winner must state their desired travel dates within 4 weeks of notification of winning the Prize to ensure the maximum chance of availability of the Prize package. Proposed departure date and tickets are non-changeable once issued and are subject to the Block Out Periods referred to in clause 11 below.
- 7. Travel is on Air New Zealand operated services only, seats are limited and are subject to availability.
- 8. The Prize package excludes insurance, visas, current passports, any meals or beverages, unless otherwise stated. Travel Insurance is not included in the Prize package. It is highly recommended the Winner and Companion purchases their own travel insurance and consider including cover for damage to, or excess on, hire vehicles. It is the responsibility of the Prize Winner and Companion to arrange a current passport and ensure it holds appropriate travel documentation.
- 9. Additional spending money and all other ancillary costs are the responsibility of the Winner, unless otherwise stated.
- 10. All Prize travel will be subject to Air New Zealand's General Terms and Conditions of carriage, to view visit www.airnz.co.nz
- 11. The Prize package must be taken in full between 4 January 2024 and 30 November 2024, and cannot be taken during any "Block Out Period". Block Out Periods include during public or school holidays in the State of South Australia, including Australian Queens Birthday and Labour Day weekends in 2023 and 2024. Individual operator block out periods may also apply.
- 12. The Winner is not eligible for any frequent flyer (including Airpoints Dollars) accrual, upgrades, companion redemption or credit of tier status as a result of winning the Prize.
- 13. Entrants must not have any criminal convictions nor anything else that may restrict them from entering Australia. The South Australian Tourism Commission will not be responsible for any issues whatsoever related to entry into Australia and disclaims all liability and responsibility for any issues, costs or expenses associated therewith.
- 14. Only ONE (1) entry per person will be permitted.
- 15. Accommodation is based on two people sharing a room on a twin share or double basis. The Winner and Companion must travel together in both directions.
- 16. The Prize package is not transferable or exchangeable and cannot be taken as cash. Any unused portion of the Prize package is non-transferable, non-refundable and non-redeemable for other goods or services and cannot be taken as cash.
- 17. No portion of the Prize or the Prize in its entirety can be on sold by any means.

The Prize package is subject to any prevailing terms and conditions of the participating accommodation/transport/services/transfer or tour providers (as applicable), and in particular, health, behaviour, age and safety requirements. In the event the Winner requests a package of greater value than that specified (e.g. requests an extended length of stay), the Winner shall pay the difference in value and no claim for the difference shall be made against the South Australian Tourism Commission. The South Australian Tourism Commission shall not be under any obligation to meet such a request.
- 23. All personal information collected by the South Australian Tourism Commission in relation to the Promotion will be held and dealt with in accordance with South Australian Tourism Commission's Privacy Statement, available at https://southaustralia.com/privacy
- 24. The South Australian Tourism Commission collects, stores and handles Personal Information about an entrant on its databases to include the entrant in a Promotion, communicate with the entrant about the Promotion and, where appropriate, award prizes. If the Personal Information requested is not provided, the entrant cannot enter the Promotion and is deemed ineligible. - 26. The Winner agrees to participate in any publicity or other such promotional activities which the South Australian Tourism Commission may reasonably require in connection with the Prize package. All visual assets including but not limited to still photography and video taken during the Prize package remain the property of the South Australian Tourism Commission and can be used by the South Australian Tourism Commission and participating tourism operators for the promotion of the Promotion and future promotional activities.
- 27. The South Australian Tourism Commission reserves the right to conduct security verification checks at its absolute discretion. The Winner may be required to sign a declaration confirming their eligibility to accept the Prize package.
